Plaintiffs filed their motion for preliminary approval of the proposed settlement on August 12, 2019. On September 11, 2019 the Court issued a tentative ruling. A hearing was held on the tentative ruling on September 16, 2019.

At the hearing, the parties addressed the Court's concern about the release language in paragraph IX.A of the Settlement Agreement. The parties have conferred and have agreed to add the clarification language: "The Release by members of the Settlement Class is not a general release" to that paragraph.

Subject to that addition, and in addition to the reasons discussed in the Court's Order of September 16, 2019, the Courts sets the following schedule:

- Younique shall transfer \$200,000 into the Settlement Fund no later than a. October 31, 2019.
- The Settlement Administrator shall cause the Notice Plan to commence b. no later than October 23, 2019.
- Plaintiffs shall file their Motion for Attorneys' Fees, Costs, and c. Expenses, and Motion for Service Award by no later than November 18, 2019.
- Settlement Class Members who wish to object must file any objections d. to the Settlement by no later than January 21, 2020.
- Settlement Class Members who wish to exclude themselves must e. exclude themselves, or opt-out, from the Settlement by no later than January 21, 2020.
- f. Settlement Class members who wish to submit claims must submit claims by no later than January 21, 2020.
- Plaintiffs shall file their Motion for Final Approval of the Settlement by g. no later than March 6, 2020.
- Settlement Class Members who intend to appear at the Final Fairness h. Hearing must file a Notice of Intention to Appear at the Final Fairness Hearing by no later than March 20, 2020.

i. The Settlement Administrator shall file a declaration or affidavit with 1 the Court that confirms the implementation of the Notice Plan pursuant 2 to the Preliminary Approval Order by no later than March 27, 2020. 3 Class Counsel and Defendant's Counsel shall have the right to respond j. 4 5 to any objection by no later than March 30, 2020.
