Class Counsel Experience and Reasonableness of Fees

- 2. My firm acted as one of the Plaintiffs' counsel in this matter. My firm has extensive class action experience. The firm represents individuals, corporations, and public entities in class action cases litigated in the United States, both on behalf of plaintiffs and defendants. My firm has served as sole lead-counsel, as co-lead counsel, or on an executive committee in numerous class actions, including cases brought on behalf of individual in various jurisdictions.
- 3. I worked on this case with my partner, Jonathan D. Miller, and our staff. Between Mr. Miller and myself, we are admitted to practice before all state courts in California and in the following Federal Courts: U.S.D.C. for the Central District of California, U.S.D.C. for the Northern District of California, U.S.D.C. for the Eastern District of California, U.S.D.C. for the District of Colorado, U.S.D.C. for the Western District of Pennsylvania, U.S.D.C. for the Western District of New York, U.S.D.C for the Central District of Illinois. We are also both admitted to the following Federal Appellate Courts: U.S.C.A. for the Ninth Circuit.
- 4. My firm kept detailed records regarding the amount of time spent by my firm, and the lodestar calculation based on my firm's current billing rates. The information was prepared from contemporaneous, daily time records regularly prepared and maintained by my firm in the usual course and manner of my firm, which are produced for the court in **Exhibit A** to this declaration. Time expended in preparing this application for fees and reimbursement of expenses has not been included in this request.
- 5. The hourly rates in my firm included in this matter are the same as the regular current rates charged for their services in non-contingent matters and/or which have been used most recently in the lodestar cross check accepted by courts in other class litigation. Specifically, our firm billed at \$600 per hour for partners,

and \$175 per hour for paralegals. The partners who worked on this case were Jonathan Miller and Alison Bernal. Mr. Miller has been practicing for 17 years. Ms. Bernal has been practicing for 10 years. Prior to joining Nye, Stirling, Hale & Miller, Mr. Miller practiced at a large international firm, and Ms. Bernal at a larger regional firm, for several years. Mr. Miller joined NSHM eleven years ago and is the managing partner. Ms. Bernal joined NSHM six years ago as a partner. Lindsey LeBlanc was the lead paralegal who worked on the case. Ms. LeBlanc attended law school before becoming a paralegal. She has been a paralegal for over ten years.

- 6. My work on this matter, which has occupied a considerable portion of my time since its inception, has precluded me from taking on more hourly work.
- 7. As of November 1, 2019, the total number of hours expended on this litigation by my firm is 251.70 hours. The number of hours reflects the extensive litigation this case required over its two-year lifespan, including opposing motions to dismiss, a motion for summary judgment, moving for class certification, and opposing a motion for decertification, as well as numerous depositions and trial preparation. We did not include any time spent traveling for the various hearings, mediations, or depositions. We cut 26 hours of travel time, or \$15,600 in fees incurred travelling. Additionally, when reviewing our expenses in preparation for the motion, and in furtherance of the goals of serving the class, we cut an additional 19 hour of work spent on the case, or \$11,400 in fees. Thus, in total, we cut \$27,000 in fees from those we are requesting.
- 8. The total lodestar based on the law firm's current rates is \$131,173 when rounded to the nearest dollar. The time described above does not include charges for expense items. Expense items are billed separately and such charges are not duplicated in my firm's billing rates. Based upon my firm records, my firm has incurred a total of \$5,974 in un-reimbursed expenses in connection with the prosecution of this litigation. The expenses are broken down as follows:

- 9. The expenses incurred in this action are reflected on the books and records of my firm, which are available at the request of the Court. These books and records are prepared from expense vouchers, check records, and other source materials and are an accurate record of the expenses as charged by the vendors. Third-party expenses are not marked up. It is anticipated that costs will continue to accrue including but not limited to travel to the April 6, 2020, Final Fairness Hearing in this matter, and service fees for the chambers copies of the motions for final approval and the motion for attorneys' fees.
- 10. I have general familiarity with the range of hourly rates typically charged by plaintiffs' class action counsel in the district where my firm practices and throughout the United States, both on a current basis and historically. From that basis, I am able to conclude that the rates charged by my firm are commensurate with those prevailing in the market for such legal services furnished in complex class action litigation, such as this, especially those involving a technical scientific aspect.
- 11. I and my partner Mr. Miller have acquired substantial experience in class actions and other complex litigation and have obtained favorable settlements as class counsel. My firm has been class counsel in the following class actions: representing a class of consumers who purchased defective car seats (*Julian v. Evenflo Co., Inc.* [Central District of California Case. P. 23; engaging in extended settlement discussions with defense counsel; addressing disputes related to the form and methods of disseminating the settlement notice; data processing, coding and mathematical modeling cross checks for damages; drafting pretrial documents; working through various disputes regarding and iterations of pretrial documents with Defendant; drafting and revising motion papers and briefs submitted to the court during the settlement approval phase; drafting all applications to seal and making appropriate redactions. The foregoing is just a general summary of the work I and my firm have done on this case to date. There are other unlisted items that can be seen in the time records produced by me in this matter.
